Taylor Schabusiness? Really?

Just in time for Valentine's Day, we have this lovely fake story from DHS or somewhere of a lady from Green Bay who decapitated her lover, etc. You can watch fake video there of her pretending to attack her attorney. Notice that he has a smile on his face while he is being viciously attacked by this large woman. I won't bore you with the rest of the details, since they just made them up, like her name. Do you really think anyone has a last name of Schabusiness? According to the people searches, she is the only one, and even she isn't really one. She is related to no Schabusinesses, so I guess she was hatched from an egg. She is only related to Coronados. She is aka Taylor Coronado, so that is probably her real name, when she is off the stage. She is related to Zertuches from . . Cotulla, TX.

Does that ring a bell? That is where Jeff Bezos is from, real name Jeffrey Preston Jorgensen. The Zertuches didn't arrive in Cotulla recently, either, since it has boomed due to shale oil. They have been there for more than a century. The current sheriff of Cotulla is Anthony Zertuche, so this actress lady is related to that sheriff. One of her great uncles Eusebio Zertuche passed recently, and we learn from his obit that they are also DeLeons.

Are you starting to get the picture? No? Collate the names DeLeon and Coronado. Do you have it? Both famous conquistadors and explorers. Ponce DeLeon, Francisco Coronado. Just a coincidence, you will say? Nope. I guarantee you it is no coincidence, since we have seen the DeLeons in my papers many times already. The Perons of Argentina were direct descendants of Ponce de Leon, just for a start. The DeLeons are crypto-Jews.

In fact, we can link the Zertuches to Bezos. See Alejandra Zertuche of this family, now CEO of ENFLUX, a high tech start up from 2020 out of San Antonio. She is also director of TransPecosBanks.

I pause to tell you something I just found on Bezos. His ex-wife MacKenzie Tuttle is the daughter of Holiday Coming. No, really. But after you stop laughing, I remind you of my recent paper on the

Cummings, who I showed were really Comyns, who were really Comnenes. So Bezos' ex is a Comnene.

I also tripped across <u>this related case</u> from last year, where Jamie Zertuche of Leavenworth, KS, supposedly killed her husband in self defense. Leavenworth is the site of a huge jail, of course. So we can be sure they faked this one as well, using actors from the same family. Both fake stories are Menare-Pigs, split-the-sexes.

But I was showing you the link between Zertuche and Bezos. A Zertuche from that area is head of TransPecosBanks. So she oversees <u>BankMD</u>, <u>started in 2019 by Moses Luevano</u>. TransPecos' Chairman and largest shareholder is Patrick Kennedy of Kennedy Sutherland LLP. All those people are related. Bezos is related to the Kennedys and Sutherlands through the Kings. One co-founder of the King Ranch was Mifflin Kenedy. Kenedy=Kennedy. One big family of crooks and con artists.

And in other news, the toxic cloud in Ohio also looks staged. How do I know? Because Netflix predicted it just a few months ago, in the film *White Noise* by Noah Bombach. A train derailment and toxic chemical release happened in that film in. . . East Palestine, Ohio, with townspeople appearing as extras. If you think that is just a coincidence, you may need to remove the mask and breathe deeply. I will be told that doesn't mean it is fake, it just means it was planned. No, most likely planned *and faked*. Strawberry Fields, nothing is real, remember. This is Hollywood we are dealing with, in cahoots with Intel. The Matrix. They need these big scary events in the news every night, so they have to stage them. The constant fear porn of train derailments and millions of dead chickens and Chinese spy balloons and food plant fires and generator explosions and rapes and murders galore not only keeps you stunned with fear and dread, helping them sell you more antidepressants and driving any revolution into the future, it diverts you from what you should be focusing on: the vaccine genocide, the torching of the Constitution, widespread illegal censorship, and the destruction of search engines—to control all information.

Tucker has devoted most of his show for the past two nights to this, which is another clue. Is this really the biggest news in the world?

Plus, the train derailment probably doubles as some huge insurance fraud. Best guess is they purposely crashed and burned these old cars to collect insurance on them, rather than just scrap them. Maybe they will claim they also had some old master paintings onboard. Maybe that's where the lost *Salvator Mundi* was. Oooo, I know, maybe they burned a few more billion in cash from the Federal Reserve—since they couldn't send it to Ukraine fast enough—in order to drive up the debt even more. That created this huge cloud of smoke, which is far less toxic than they are claiming. If it were really toxic they would have cleared the town. You wouldn't just have some claims of a few dead fish and a dead cat or fox (which are easy to fake). They tell us 3,500 fish died, but I have seen no pictures of that. It is just a claim. I will be told they have witnesses on Tucker Carlson, claiming they are having rashes and feeling sick. Except that they don't have any visible rashes. I guess make-up didn't have time to fake those. The guy claiming that is named Nathan Izotic. Pretty rare last name, so I looked him up. He IS listed, but his mother Barbara has beenvery conspicuously scrubbed. So I did a Google search on her. At Clustrmaps.com we find she has been in 18 locations since 1991, starting with San Clemente, CA, where she was living in an expensive house on Vista Marina. So that's a bit odd. With more searching, I found this same Barbara Izotic has been in the news before. She reported being the

victim of assault and battery in 2013, and charges were filed. A people search finds she is related to Klopp, Hatton, Wagner, and Yhelka.

Izotic is a variant of Izod, as in the famous clothing brand. The surname is a very old peerage name, and they came over with William the Conqueror in the Norman Conquest. It comes from Isolde, daughter of King Mark in the tales. They are currently related to the Nixon-Brownes, one of whom was recently a TV producer for CBC Canada. This also links us to Jack Browne, Baron Craigton, Privy Counsellor. Craigton was the son of Edwin Izod. They are also related to Hepburns, so you see the link to Hollywood.

Also curious is that Tucker ran video of a lady nearby claiming her chickens died. Chickens again. But in the video we see red marks all over her face. Why not ask her about that?



Next day: Greg Reese has already posted a new video at Infowars to answer my claims here, though as usual when he is up against me, Reese is out of his pay grade. As I have said before, Reese has done some good work and Infowars is often on the right side of current issues like vaccines, but that isn't the question here. The immediate question is what this event in Ohio was. Reese doesn't answer my other points here, like VC burning white, but he does address the movie *White Noise*. He explains it away as predictive programming. What is that? He tells us,


It's purpose is to psychologically trick the minds of the masses into accepting major traumatic events that would otherwise be resisted.

Does that make any sense? Not really. Back before predictive programming, the masses had zero resistance to believing the news, and they still have very little. So predictive programming seems like an unnecessary risk. Once people see these events are being perfectly foretold, it just creates suspicion, and that is exactly what we have seen. People's belief of the event isn't increased, it is *decreased*. People know things like this can't be coincidence, so they either have to be signs from the gods, or signs from the Earthly controllers, and most people are going to go with the latter, as they should. There is no reason for the gods to gaslight us, but every reason for the controllers to do so. So then predictive programming just becomes the controllers tipping their hands to us, to *increase* our

disorientation. They are telling us they are fucking with us as they fuck with us. It is like the bully poking you and saying, "Yeah, and what are you going to do about it?" So, you see, it is just straight up sadism.

Notice whom Reese quotes on this predictive programming: Michael Hoffman and his book Secret Societies. Hmmm. We have seen these Hoffmans in my papers over and over haven't we? Do you really want to get your information on this or anything else from a Hoffman? I don't. Hoffman is obviously a Jew controlling the opposition by telling some amount of truth and flipping you on the rest, as we have seen many others do before him. For example, in that book Hoffman correctly admits the existence of a shadow government, but then sells the Kennedy assassination as real, being a ritual murder of a Catholic. The usual hogwash, since the Kennedys are related to the Hoffmans, and they are both prominent Phoenicians from way back.

Reese then quotes Sarah Elkhaldy:



That's the photo she chose herself to front her own website, which she calls thealchemist.community, and where she sells herself as a mystic and leader in the fields of Spirituality and the Esoteric Arts.

Sarah hosts retreats and seminars internationally on Alchemy, Ascension, and Shadow Work.

Shadow work? Not sounding too good off the top, is it? Well, it gets worse. Elkhaldy tells us that there is some sort of higher "law of Nature" that says it is OK for the Phoenicians to scam us if we remain silent. Silence, or even ignorance, is taken as acquiescence, which we are supposed to believe absolves the dark forces of guilt or responsibility. Is there any chance that is true? No. Is there any chance the Phoenicians believe it is true. Very little. It's just a pretty bald psychological ploy, on the low level of all the other ones these shadow workers use: it is meant to make you think the gods have given them a pass, so maybe you should, too. It is your own fault for not making the connection, speaking out, and stopping them. Everything is YOUR fault and nothing is theirs.

But even once we figure that out, we still have the question: is the "real" event real, or just as fake as the one in the movie predicting it? Reese's theory of predictive programming has nothing to say about

that, because it could be either way. But I have shown we don't need to go to theory to figure it out. I have now unwound hundreds of these events, many of which were predicted in this way. Were any of them real? No. Some of them had real components, as does this one in Ohio. They staged a real crash and created real smoke. But they also do that for Hollywood movies, so it doesn't mean any of this is real. It doesn't mean this is a huge important scary event, one that should take up all your mental energy this week, add to your considerable dread, or send you down into a bunker. You shouldn't pause the revolution or forget about the vaccine genocide to worry about this event. For that is its real purpose: misdirection. Eyes-off. Chaos creation.

An hour later: The Feds have <u>now officially declined disaster relief to Ohio</u>, confirming my reading here. FEMA is claiming this isn't in their line. When was the last time you heard of the Feds ignoring a big disaster like this? Never? So they apparently understand this is just Hollywood.

February 19: More evidence continues to come in that this was all staged by Hollywood/Intel. Plus, I remind you, Hollywood is still in partial abeyance after Covid, with tens of thousands of actors out of work, maybe permanently. So those people had to find something else to do: enter Intel, who has hired them to sell its fiction. Sold as "another bizarre coincidence", it turns out local news was telling residents to get free biometric tracking devices in case of a disaster a week before the disaster. The local fire department was handing them out for the entire week before the event. That's convenient, right? But why do that if this was a all fake? Wouldn't the devices register nothing harmful, showing up the fake? Yes, when they were used by real people. But those people could be ignored as being upwind, blocked, or lucky. More importantly, the devices—when worn by Intel actors—would give legitimacy to the whole event. Hundreds of people could be brought in with positive readings, seeming to confirm the event as real. Which is precisely what has happened.



Added February 25, 2023: Erin Brockovich has now arrived in East Palestine, and is being used as one of the talking heads selling the event in the media. Once again proving it is fake. Why do I say that? Because her own famous event makes as little sense as this one. We are supposed to think she came out of nowhere to spearhead a legal team that won a third of a billion from PG&E in California in 1993 for chromium poisoning in the water. She is variously called a whistleblower or a legal clerk, but she was neither. A whistleblower is someone who works for the company, and she never worked for PG&E. She had no legal background, either, and the story of how she got involved makes no sense. Her bio at Wiki glosses right over it, and in the movie we are told she begged her own lawyer for a job after he lost a traffic case for her. Right. So he assigns this 33-year-old single mother with no legal experience to be his lead investigator in this huge case? They admit at the beginning of the movie she had no experience in anything and no degree. What they don't stress is that she had already been married and divorced twice at that age, allegedly being married to Brockovich for only one year. She was married to Eric Ellis for 14 years after that, so why did she stay Brockovich the whole time? Her maiden name is Pattee. It could be because Steven Brockovich was and is a rich financial advisor, out of Reno. He is now First VP at Wells Fargo Financial, and previously worked at Morgan Stanley as a First VP. He was at MorganStanley at the time of the PG&E event, which may be a big clue. According to LinkedIn, he was in Reno back to 1988, so how exactly did Erin end up in Thousand Oaks in 1993? If nothing else it indicates her depiction as a poor gum-smacking manicurist type in the film is misdirection. Her beat-up old car does not match the ex-wife of a Morgan Stanley guru, so there is something we aren't being told. We are told she didn't get any alimony or child support from him, since her third child was born after they divorced, but they must really think we are stupid. Divorce has nothing to do with it. If the child is his, he must pay child support. Everyone knows that. And if they were married, she would also get alimony, short of a very successful pre-nup of some kind. So we are definitely in the grip of a con here, the only question is how deep does it go.

Also weird: there are no pictures of Erin Brockovich from that time on the internet. No pictures of her looking early 30s or younger. In all of them she looks over 40. She is supposed to have been a beauty queen, so you would expect pictures of her from that at age 21, but nothing. I guess it was a beauty pageant with no pictures.



Not exactly Julia Roberts, but I do note a Habsburg jaw. Some places say she went to Kansas State, Manhattan, while others say she only went to Wade Business College in Dallas, a two-year college. But if she graduated there it was in Applied Arts, not business or anything similar.

To pad this out, I decided to watch the whole film, which I had never seen. We are supposed to believe that Brockovich was just being used as a filer in the law firm when she saw medical samples in real

estate files. Why someone who was just hired would be studying the contents of these files is never explained, nor is it explained why she would drive all the way from Thousand Oaks to Hinkley (past Barstow) just out of filing curiosity. Why not just ask the guy who gave her the files?

Oh, and by the way, the damage to Julia Roberts' car doesn't match the impact. She is hit behind the back wheels, spinning her around. But when we see the car after it has been repaired, only the doors have been replaced. There is no damage to the rear side panel or back wheel on that side. Just to prove to you my eyes are open once again.

And this: Julia is wearing padding in the movie. She isn't that chesty. She has a house in Taos, where I lived for 14 years, and one of my friends was the caretaker there. Her husband used to play volleyball with us and she would come watch occasionally. So I have seen her in person. You can't fake her nice legs and small waist and pretty face, but you can fake that chest. Sorry to disappoint you.

Also interesting is min. 24, where Erin says she is sure she will fuck up her kids eventually. Sort of revelatory, since that guy and her ex-husband both claimed she abused her kids in real life.

But back to the case. This was supposed to be a pro-bono real estate case the firm had taken, involving offers to buy houses in Hinkley by PG&E. Two problems: one, that law firm didn't deal in cases like that. Two, any law firm working on a case that like would have smelled blood immediately. It would not have required some hot broad in high heels to tell them this was suspicious. So none of this is believable from the first word. The only reason to have Brockovich involved here was as eye candy. That, or she was some kind of front for her ex-husband.

Next we learn PG&E was paying medical bills for these people in Hinkley while waiting to buy their houses. Right, because that makes sense. That wouldn't give those folks the idea PG&E was to blame, right? PG&E just pays people's medical bills to be friendly. PG&E was even telling people about the chromium in the water. So none of that is believable, either. It is for people that think *Star Trek* is a documentary.

In the film, we are supposed to believe PG&E had a seminar for the residents of Hinkley, telling them about the chromium in the water, but lying and saying it was "healthy" chromium3, not chromium6. Does that make any sense? Would PG&E really be stupid enough to start talking about chromium?

Next, we are supposed to believe the local Lahontan County water board gave Julia Roberts (also 33 in the film, by the way) unfettered access to all their files and their copy machine, just because she winked at them. Only one retarded guy works in that office, apparently. But in real life, she would have had to have told them she was looking for indication of chromium6, which would have locked them down immediately. You can be sure they were under control of PG&E.

Next we are told there is a one-year statute of limitations on suing for water contamination, once you are informed of it by the government, even if they lie about it. Of course that is not true. When fraud and lying are involved, there is no statute of limitations. As just one example, think of Nazi loot still being returned to owners. That was 77 years ago.

Next, we see Julia Roberts in jeans and pumps dipping vials into the creek right by the big PG&E plant. Doing her own chemical tests. She climbs barefoot down into an open storm drain. So that's believable. Remember, the real Erin Brockovich said this movie was 95% true. She even had a cameo in it.

Next, they tell us Brockovich's firm didn't think they could make the case stick because PG&E headquarters in San Francisco could claim they didn't know what PG&E Hinkley was doing. Again, false, since PG&E would be liable no matter what. PG&E is PG&E, and if San Francisco didn't know what Hinkley was doing, they should have. Ignorance is no excuse. So this is just another diversion, meant to explain why they went for arbitration instead the full suit. As usual, this is for people who don't know anything about the law.

In the same line, the next thing we are told in the film is that if the firm filed suit, PG&E could file a demurrer, attacking each complaint and asking for dismissal, and "it's all over". Again, false, since it doesn't work like that. Yes, PG&E could do that, but given the amount of evidence presented by the film, the judge would never agree to dismiss, blocking all further lawsuits. For that to happen, the law firm would have to have nothing, just a lot of empty claims. And even then, that wouldn't prevent any future lawsuits. Even a finding for PG&E *after* the suit wouldn't be "it's all over", since you have appeals. So if you can't prevent future lawsuits after a suit, you certainly can't prevent them before a suit. No judge can stop all future lawsuits just because the first law firm was incompetent. Some judges have tried to do that, but it is illegal.

My favorite part of the movie is min. 2:00:00, when Erin and George visit the lady who has had her breasts and uterus removed due to cancer. She lives right next door to PG&E and we can see it in the background. She is out in her garden, with the water on. If I thought any of this actually happened, I would have no pity for her. All these people have known their houses are poisoned for more than a year, but no one thought to move? You will say they can't afford to move. Anyone can afford to move in an emergency like that. If a nuclear bomb exploded next door, you would find a way to get out. You wouldn't just sit there and melt. Sell everything you own, take out a small loan, buy a camper, and drive off. They wouldn't have to go far. Most people have relatives. Same thing in Ohio now. If that were real, you don't just stand there and watch all your chickens die, with a mushroom cloud in the sky, and do nothing but meet in the highschool gym. If the wind is blowing NE, you drive SW. It isn't brain surgery.

[Added March 3, 2023: A reader sent me this article from 2000 at *The Guardian*, which I think is mainly more misdirection but which does contain a big clue supporting my thesis here. There we find that the author Ed Helmore (or someone at *Salon*) talked to Brockovich and Masry personally, by phone I assume, and he reports that

Brockovich herself did not seem to understand the process of private arbitration or the fact that the records of the case remain secret. Her former employer, Masry, was unable to explain the process either. 'Why are you being stupid?' he retorted. 'It was a complicated \$333m settlement. Are you an idiot?'

That sort of leapt off the page at me, and you see why. If it is true that Masry and Brockovich did not understand the process of arbitration, that can mean only one thing: they are not who we are told. They are actors playing a part. But if they are actors, that would imply that all the victims are also actors, and that the whole thing was another stageplay. The whole thing was faked by Hollywood, and the original event was just as fictional as the later movie. In which case no money was paid out at all, except actors fees. In fact, the amounts listed in the article are more in line with actors fees than with a payout for fatal metal poisoning. \$100,000 for such a thing is a ridiculously low sum, as you should know. That will buy you about a week in a hospital these days, with major treatment.]

The movie ends by saying the law firm has seven other cases pending against PG&E. That was in 2000. Funny, since according to Wikipedia, only one of those cases went anywhere. That would be the Kettleman Hills case, but I couldn't find any information on that. It appears to be mixed up with a hazardous waste facility there with no connection to PG&E. Either that or an oil pipeline that runs hundreds of miles, since Kettleman Hills is nowhere near Hinkley. The event in Hinkley had nothing to do with a pipeline.

This attorney she was working for, Ed Masry, also comes out of nowhere and disappears into mist. Check out his Wiki bio, which is a joke. We are supposed to believe he became an attorney with no bachelor's degree. He came out of the army. According to his bio, this huge PG&E case was the only thing he ever did. Despite having PG&E on the hook for literally billions, in what should have become a superfund site case, Masry and Brockovich pursued arbitration rather than go to court. Brilliant. They told their clients they would be dead before they got anything, since it would take 15 years of court battles. So they accepted 333 million from PG&E, with attorneys taking 133 of that. Brockovich got about 2 million. The whole arbitration thing is a big red flag, since it was just playing right into PG&E's hands.

We also have confusion on the legal companies involved, since we are told that Masry and Vititoe was the firm, but also that Girardi and Keese was the firm.



This just pulls in more red flags, since Thomas Girardi married reality TV star Erika Jayne Girardi, and was later convicted of defrauding many clients of over \$100 million by a ponzi scheme through which he illegally channeled money, including to his wife's accounts. Multiple mansions and jets were seized. Girardi also represented multiple plaintiffs from the 2017 Las Vegas fake shooting event, indicating everything he was ever involved with was a fake. Girardi's CFO Christopher Kamon is also being charged in Chicago for massive fraud in the 2018 Indonesia airline crash, indicating that may also be a fake.

So given her links to these people, it is a bit amazing Brockovich is showing her face in public right now. She is relying on the public's ignorance of this and everything else.

I should also remind you of her 2012 debacle in LeRoy, New York, where four students were exhibiting strange symptoms. She claimed a 1970 train derailment in Lehigh was the problem, and pretended to take soil samples for testing. I remind you she is not a scientist or an expert in testing for chemicals. She wasn't in 1993 and still isn't. She never reported her findings and local doctors

determined it was psychosomatic. Once the press left their symptoms magically disappeared. I draw your attention to that train derailment highlight. Just a coincidence, I'm sure.

This Erin Brockovich case seems an awful lot like the Karen Silkwood case of 19 years earlier, doesn't it? I used to get the two cases confused, and maybe you do, too. A pretty lady whistleblower, a big Hollywood movie, Meryl Streep plays one, 16 years later Julia Roberts plays the second. So ask yourself this: why didn't Erin Brockovich ever get taken out, like Silkwood allegedly did? I suggest it is because she was a front for PG&E the whole time. The lawsuits were faked to limit their damages to a few million, when a real class-action lawsuit should have cost them billions. According to the numbers posted, the victims only got around 200 million, and that doesn't include whatever went to Girardi and Keese. So the victims may have gotten less than 100 million all told, which is peanuts for a superfund site. And this mess is still going on, since PG&E is still countersuing various parties and firms, to make sure no real law firms touch it. Whatever is going on, it isn't what we were sold by the media and Hollywood, that's for sure.

Another possibility is that there isn't any water contamination there at all, and someone wants to get those people out in order to mine for uranium or something out there. It has worked, since the place is now a ghost town. It would be interesting to know who actually owns it. If this is the answer to the mystery, I doubt it is PG&E.

In support of that guess, we find in the film that PG&E supposedly used the chromium as an anticorrosive in natural gas cooling towers, then dumped the excess water into ponds. But they just failed or forgot to line the ponds, allowing the water to seep into the groundwater. That makes no sense for so many reasons. If you don't line the ponds, the ponds are pointless. You might as well dump the excess water directly into the streams. You will say they had no permit for that, but do you think they had a permit for unlined ponds? Who would give them a permit for that? If they can do one illegal thing, they can just as easily do the other. You will say the state was monitoring the streams, but if so, the state could just as easily monitor the ponds. The state was either in cohoots or it wasn't. If it wasn, then it didn't matter where they dumped it. If it wasn't, then the state would monitor both the river and the ponds.

Since none of these stories makes any sense, they must be covering up something even bigger. I noticed in the film they never mention natural gas. That may be because they assume you know PG&E stands for Pacific Gas and Electric, but since we have seen they assume you know nothing at all, that is doubtful. Julia Roberts doesn't even mention natural gas when she is talking about the cooling towers, which is odd. What are the towers cooling? Natural gas. Why does it matter? Because, as I suggested, this may be cover for something else, and they don't want you to remember that as with oil, natural gas requires drilling. While you are drilling you may discover something else: something even more valuable. Gold, platinum, uranium, or other things. In which case it would be great if you could move as many people out before you start extracting it. It has happened before, think of the mining done on Native Reservations, where they forget to tell the Natives what the mines are worth.

March 3, 2023: In another case of serendipity, I was researching Louis Leakey today for my current paper, and was reminded of his work in the Calico Mountains in California, which caused a huge controversy and split him from his wife Mary. This dig just happens to be very near Barstow and Hinkley, which sent up another red flag. Mary Leakey admitted no human artifacts were found there, with Louis and his new lady Ruth Simpson just making up some story about "scrapers". That was back in 1963, so there were already mysterious digs in that area, probably as cover for something else. I remind you that Leakey had ties to British Intelligence, and he worked for them in Kenya in the

MauMau wars. The Calico site is only ten miles from Hinkley PG&E, and there is an auxiliary airfield just a mile outside of Hinkley. Despite the fact that there is already an airport on the other side of town: the Barstow/Daggett airport. Studying Google maps, we find the tiny town of Lenwood/Barstow has a Marine Corps Logistics Base and a huge railyard. Why? Where does this railway go? It goes south to San Bernardino, hitting the coast at Dana Point and then running down to San Diego, where we finally hit a terminal as large as the one in Barstow. The 10th avenue Marine Terminal. There is also a big rail terminal in Yermo, just east of Barstow, at the Del Taco historical site, just two miles from the Calico site. What is that? It is just what you think: the original site of the Del Taco stands. But why would that require a big railyard? Shipping out millions of tacos, are they? And why would this sparsely populated area need so many airports and rail terminals? So let's follow the railway north. It goes to Las Vegas and through miles of nothing to Salt Lake City at last.

So I repeat the question: why would the tiny town of Barstow have a giant rail yard and be connected directly to San Diego and Las Vegas? Well, let's follow the rail west instead of N/S. It goes to Mojave Air and Space Port, then turns north, dead-ending in Searles Valley and Trona airport. But what does it hit before it gets to Mojave? Edwards Air Force Base, which covers that entire area north of Lancaster. Aha! So we are starting to get somewhere. Edwards is only 20 miles west of Hinkley. With Edwards so nearby, the Marines would not need a special camp in Barstow unless something important was going on *right there*.

The connection to Edwards indicates to me my guess was right: it is probably uranium they found in the Hinkley area, not chromium6 poisoning. So the whole Erin Brockovich story was cover for that. Which means. . . the East Palestine event may be similar. It may be manufactured not just to put something in the headlines this week besides the vaccine genocide, it may be manufactured to move people out, so that the military or industry can move in and buy up property for some reason. Something may have been discovered there as well. East Palestine isn't anywhere near Wright-Patterson AFB, so we can mark that off. The only red flag I found on short notice by studying Google maps was HD Sonic drilling, a company that is strangely large to be found in this little town. Do they have a lot of local work? If so, that would tend to confirm my line of questioning.

I am also reminded of the 2011 Spielberg movie *Super 8*, which took place in the fictional town of Lillian, OH. When a train derails, the military quickly arrives and fakes a wildfire to get the town to evacuate. Spielberg spins that spin by telling us an alien was onboard the train, being held in captivity by the Air Force. So I guess we are just lucky no alien stories are yet involved in the East Palestine script. Maybe we have that to look forward to.
