## Kamala Harris is Mostly White

## and her genealogy proves it

This paper ranks #1 at Yandex on the search **Kamala Harris White**, with no quotes. As usual, Google has illegally removed it from all searches. So have Bing and Yahoo, refusing to list any results on the stated search and misdirecting you into the opposite results.

[October 5: Wow. After heading that search for two months, and even solidifying its position in the past couple of weeks as I began responding to Candace Owens' youtube videos on the same topic—yesterday I held down the top three positions, with my own site and republications—suddenly today this URL is not to be found at Yandex. Someone obviously made a call to prevent any searches leading to this paper. However, tapnewswire.com is still republishing this and comes in at #5. And they do provide a link, thanks!]

If anyone cares about the truth anymore, this is it. There is the usual hubbub in the news, with both sides avoiding all facts, but although Kamala *is* part Indian on her mother's side and part black on her father's side, if you add up totals she is more white than anything else. And the white lines are heavily Jewish, as we would expect from someone who likes to marry Jews like this guy:



That's Doug Emhoff young. Almost no one knows the "second gentleman" of the US is Jewish.

You should be able to tell Kamala is mainly white/Jewish just from looking at her, or noticing her promotion, but most people's eyes aren't too good so let's be scientific about it and look at bloodlines.

<u>Master genealogist Tim Dowling has it all laid out for us on his huge site.</u> He isn't hiding it and so the truth is easy to find. Which makes it amazing that no mainstream reporters can seem to locate it.


Let me simplify it for you. Jewish we will count as white. So, say she is half white on both sides. In that case she is in total half white, a quarter black, and a quarter Indian. So twice as white as anything else. If she were only  $1/3^{rd}$  white on both sides, she would still be as much white as anything, being  $1/3^{rd}$  white,  $1/3^{rd}$  black and  $1/3^{rd}$  Indian. So she would have to be only  $\frac{1}{4}$  white on both sides for her to be predominantly non-white.

Snopes has already conceded her mother is half-white, being listed as Caucasian on Kamala's birth certificate. So let's do a little simple math. How white does she now need to be on her father's side, to make her mostly white? Well, that gives us this equation:

 $\frac{1}{4} + x = 1/3$ 

That gives us  $1/12^{th}$ , but that is total. So we must double it to get her paternal side: if she is more than  $1/6^{th}$  white on her paternal side, she is white. Meaning, if we go back a few generations and find at least 1 of 6 ancestors are white on that side, our job is done.

As it turns out, that is quite easy to do, since her Jamaican father is listed as Jamaican instead of black for a reason: he mostly comes from Jamaican slave owners, who were white. And Jewish. Again, you can tell that just by looking at him:




Amazingly, they have scrubbed that picture and all others from his Wiki page.

But we are being scientific here, and mainstream scientists don't accept visual evidence, since they are not visual. The boys in the barbershop can see this, but mainstream scientists can't. So let's return to the genealogy. Even in the Harris line, Kamala Harris isn't black. The Harrises come from Samuel Constantine Harris. Note the Phoenician name Constantine. These Harrises came over to Jamaica from Ireland in the 1700s, and they were closely related to Watsons, Grahams, Wallaces, Townshends, and Roberts. They were not slaves, they were slaveowners, as you can see here. That is ucl.ac.uk, in case it gets memoryholed. University College London, list of British slaveowners. More than that, they were slave *traders*. The names Graham and Townshend indicates they were peers. Nobles. The Townshends were and are Jewish/Phoenician peers, see Pete Townshend for your visual here:



If you will remember, Pete beat a pedophilia rap by claiming he was doing research. Wiki mentions the case, but totally whitewashes it for Pete.


In about 1900 one of these Harrises had a child with a Christiana Brown *Chrishy*. Was she black? Only half at most, since her grandfather was Col. Hamilton Brown, a white slave trader from Ireland:



He founded Hamilton Town, now Brown's Town. Dowling tells us his wife was a slave, but she doesn't have a slave's name: Kate Williams. So more likely she was an indentured servant from Ireland. Thousands of them were going to Jamaica at that time. Plus, I don't trust that photo of Christiana that I got from Geneanet. Look closely at her head: it has been repainted. Especially bad are her hair and her chin. I think they were trying to make her look more black. At any rate, her partner Joseph Alexander Harris looked like this:



Not black. Jewish, as I said. Don't believe me?



That is posted on his Findagrave page. Three different mentions of the Levys there.

Next, the Harrises marry the Finegans, in about 1945. Was this Beryl Finegan black? No more than half if at all, because her father was Patrick Alhanasous Finegan, yet another Irish slaver. Alhanasous is another Phoenician pointer, probably a slur or misspelling of Athanasius. His mother was Mary Graham Watson, Graham and Watson being two more big peerage names from Scotland




MyHeritage posts that picture of Beryl, but we have no reason to trust it. MyHeritage has multiple listings for her, in one she is Beryl Harris nee Finegan, and in another she is Beryl Finegan nee Christie. Tim Dowling confirms Christie as her maiden name and has added that photo since this paper was first published (along with several others), but then he tells us her father was Finegan. So that makes no sense. It looks to me like her second husband was Finegan, not her father. So there is a lot of misdirection here.

In fact, I could only confirm one black person among Kamala's eight great-grandparents. That would be Orah Allen, whom we have a fairly trustworthy picture of. Even she is probably half white, since her father is listed as John Isaacs Allen—a Jewish name. But if *even one* of Kamala's four paternal great-grandparents are white, we would be above 1/6<sup>th</sup>, proving she is mostly white. I just proved that and more than that.

So all this fluff about Kamala being a DEI hire is the usual misdirection. She didn't get where she is by being black or Indian or even a woman. She got there by being of these old families like the Hamiltons and Grahams and Wallaces, that is, by being a Phoenician. There is no inclusion, the diversity is a mirage, and forget about equity or fairness. If you are from the Families, you get promotion whether you deserve it or not, and if you aren't you get buried, slandered, and ignored. And even if you are from the Families, you have to do what you are told or you will be thrown unceremoniously from the bus. Which I highly recommend you do, since the bus has always been on a glittering road to nowhere.

Added September 26, 2024: I just watched Candace Owens' video from today, where she continues my investigation into this. She finds a second wife for Kamala's paternal grandfather Oscar Harris, a white woman named Vioris Cambridge, suggesting this may be Kamala's actual grandmother, rather than Beryl Finegan. But we already knew about Vioris from the link to Geneanet above, where she is clearly listed. Tim Dowling isn't hiding it. But Candace does get us restarted by republishing this picture from Kamala's own book:



I have posted it really big so you can study it closely. That is supposed to be Kamala's Indian mother (looking at least half-white or Hispanic), Kamala, and her paternal grandfather Oscar. Oscar doesn't look black at all, does he? Again, more like Hispanic/Cuban. But that's not why we are here.

IT'S A PASTE!

As usual, that picture is a fake. It has been pasted together from three photos. They are all in a different light, and that is especially obvious with the baby Kamala, since she is way blown out. See how she is about ten shades lighter than the other two people, like a 1000-watt bulb is right on her? Her forward arm looks really strange, since it is so blown out it has almost disappeared in white. You will say it is because Kamala is getting reflected light from the white gown she is wearing. Except that her mother is right next to her, just a few inches away, but the gown is not blowing her out in the same way. The gown should be acting like an actual reflector, lighting up her mother's dark side. But it isn't. Her mom has normal shadows on that side. That's why the picture looks so weird at a glance. Even the background looks fake, like a greenscreen. All the edges where the figures meet the background look unnatural.

So what are they hiding? Is that even Kamala? I think so, since she has a strange right ear. See how it is pointed? She never shows her ears now, and that is why:




The baby picture is from 1965, so Oscar would be 51, which looks about right. So again, I don't know what they are hiding or trying to prove with the paste. The only reason I can see is that they are trying to sell us that Cuban-looking guy as Oscar when it isn't him. They have replaced him because his real looks would be a dead give-away.



We already have confirmation of that from that wedding photo Candace found of Oscar and Vioris. Other than the bald head, I don't really see a match to the Cuban Oscar. Regardless, you can see they both look very upperclass. They don't look like poor Jamaicans, do they? So let's work on that assumption.

I did discover many things Candace didn't, starting with this:



That's from the cache of pages at Geneanet I link to above. Look closely. Oscar Harris was aka. . . Oscar Wilde. What! That's because Oscar Harris isn't his birth name. He was born Oscar Wilde Brown. His sister was Ena Brown. So why was he named for his mother? The usual reason, we

suppose: his parents weren't married at his birth, since his father was probably not an "agricultural exporter" but a slaver. The goods he was exporting were slaves. And Christiana Brown was possibly a slave or indentured servant.

But we have even more misdirection, since Christiana's birthname wasn't Brown, either. It was Chrishy. The name in italics is usually the birthname at Geneanet.\* So Oscar's birthname should be Oscar Wilde Chrishy? Dowling actually has two pages for Oscar, and on <u>the other one</u> Wilde is the last name in italics, so a lot of stirring is going on over there. I now think both the name and the picture are wrong, meant to misdirect us.

And we see even more stirring: Christiana's mother-in-law was named. . . Elizabeth Brown. So although I don't think Christiana's maiden name was Brown, if it was it indicates she married a cousin as well.

The other big thing Candace missed is that Tim Dowling admits Oscar never married Kamala's grandmother:



That page is in French, but *marie* means married and *relation* means they only had a relationship. Beryl did later marry Lawford Newland in 1944, when Kamala's father Donald Harris was about six. Oscar's father Joseph Harris also did not marry Christiana Brown Chrishy, they also having only a relationship.

Also interesting is that we hit the peerage Watsons of Perthshire, Scotland, twice in these pages, once with Catherine Jane Watson, wife of 3g-grandfather Thomas Harris; and Mary Graham Watson, wife of 2g-grandfather Patrick Finegan.

Another thing Candace missed is the goldmine hiding behind Vioris Cambridge, Oscar's second wife. Not only was she white, she was the daughter of Vivian Stanley Cambridge. Sounds very aristocratic, doesn't he, since that is three peerage names stacked. He is well scrubbed, not appearing in the peerage proper, but we can easily link him to the Stuarts anyway. Through the Parchments he links us to the Saunders, whom we recognize from Frances Stonor Saunders. Ben Franklin was a Saunders. We also link to Captain Andrew Bromfield, who links us to the Murrays of Scotland. Through the <u>Cranstons we then link to Elizabeth Stewart</u>, whose great-grandfather was King James of Scotland, son of Margaret Tudor. But Vioris isn't just a royal Stuart in one line, she is a Stuart in several lines. Through the Parchments again we soon hit Sarah Maitland. Dowling scrubs her, but the Maitlands are first cousins of the royal Stuarts. Think of actor Jimmy Stewart, real name James Maitland Stewart.

October 3: Candace found more proof of that, since she tracked down a picture of Donald Harris' half-

brother Christopher, who signed Oscar's death certificate. Christopher is the son of Vioris Cambridge:



Even whiter than Donald, as we would expect. And it is curious Tim Dowling scrubs him off Vioris' page. He is also scrubbed at Wikitree. But that isn't why I am republishing it. It is because Candace overlooked something, didn't she? How about that medal he is wearing? Do nobody Jamaicans normally wear British peerage medals? No, but guys in the direct line of Stuart kings do. That isn't a war medal since Christopher was born in the 1940s. The Seymours were St. John of Jerusalem, but that medal isn't that, though it has the right colors: red and white. It also isn't St. Michael, since it has six arms, not seven. I looked hard for it online, but had no luck. One thing for sure: it isn't a bobsledding medal.

**[Next day**: A reader recognized it as Order of Canada, their answer to the British orders like Garter and Thistle. It is the second highest honor after Order of Merit, and Prince Philip was Order of Canada. It does not confer knighthood but does qualify you for a coat of arms. Order of Canada has been awarded to actual Nazis as late as 1987. See Peter Savaryn, WaffenSS, telling you who is running the show in Canada. Amusingly, the motto on the medal is "desiderantes meliorem patriam", "they desire a better country". Yeah, I bet they do. So do I.

Christopher has several more medals now, including the Order of Ontario, a Canada's Citizenship Award, and The Queen Elizabeth Diamond Jubilee. He has volunteered with the Ottawa-Carleton police for the past 60 years and the RCMP for 26 years.

So we have more unexplained connections to Canada. Why did Christopher move to Canada 60 years ago? Remember, Kamala went to junior high and highschool (ages 11-19) in Montreal while her mother was working at McGill at the Jewish General Hospital, so her uncle was already there. Kamala was at prestigious Westmount HS, where Leonard Cohen and other famous people went. She then went to Vanier College in Montreal for one year before transferring to Howard. She has said that when she moved to Montreal, white children wouldn't play with her because she was black. Right. However, you may be interested in this: <u>one of her classmates from Westmount, Dean Smith, is quoted as</u> saying she didn't have any boyfriends. Despite being admittedly beautiful in those years, she didn't go to prom and started a club for girls without prom dates! Kamala's girlfriend Wanda Kagan moved in with her in highschool. Hmmm, what could it mean? Well, Wanda looked a lot like Kamala, and Kagan is a Jewish name.



Are you starting to get the picture? If not, try this quote from the same article:

Randee Rosenthal Glassman recalled becoming fast friends with Harris. 'I remember her laugh,' Glassman told Daily Mail. 'She was pretty but I don't really know if she was popular with boys.'

Another Jewish best friend.]

So that brings up this very good question: how did Oscar Harris, Kamala's non-black black grandfather manage to marry a white Stuart from the royal house of Scotland? He would have to be from royal lines himself, and we find without much effort that he was. In these same pages at Geneanet, we just keep clicking on these Harrises, until we hit Mary Parsons in the 1700s. Her grandmother is Margaret Welche, whose mother is <u>Elline Seymour</u>. She is of THE Seymours and Greys, putting Kamala in the DIRECT line of the Duke Edward Seymour, the Duke Henry Grey, the Earl Henry Herbert, the Princess Mary Tudor, and King Henry VII Tudor:





Since Mary Tudor married Louis, King of France, Kamala is also a 16g-granddaughter of Louis XII. She is also a first cousin many times removed of the Duke Thomas Howard,



who we saw was fake-executed in the Ridolphi Plot against Elizabeth I. That's because he was the second cousin of Elizabeth, which makes Kamala a third cousin of Queen Elizabeth, many times removed. She's a *first* cousin of Henry VIII.

Wow. Chew on that a while. It didn't take much work to discover that, since it is all up at Geneanet and only requires a couple of dozen clicks. So it is sort of strange that Candace and her team missed it. So not only is Kamala's Jamaican line barely black, it actually leads *straight* to the white Kings of England and France.

So what else does that tell us? Well, it tells us that Kamala's grandfather Oscar Wilde is probably really related to the famous Oscar Wilde, and may even resemble him. That is probably why they had to paste someone else into Kamala's baby photos. <u>As we saw in my paper on Wilde</u>, he was from these same lines, being a Graham, a Murray, a Stanley, and a Stewart. Wilde's wife Constance Lloyd was a Watson. And remember, Oscar Wilde had a son named. . . Vyvyan. Vyvyan=Vivian, which we just saw with Vivian Stanley Cambridge. So something is going on here we aren't being told. There is still a mystery I haven't solved.

So let's keep working on it. Constance Lloyd wasn't just a Watson, she was a Stanhope and Fitzroy, making her a direct descendant of King Charles II. Tim Dowling of Geneanet is also a 7<sup>th</sup> cousin of these people through the Clintons. This links us to the Seymours in about 1700, so we have found a hard link between Oscar Wilde's wife and Oscar Harris through the Seymours. Still, that doesn't really

explain why Oscar Harris was named for Oscar Wilde, since the link isn't that close. There is some closer link and I suspect it is through the Watsons of Perthshire, Scotland, since that would give us a link around 1900. But given all the scrubbing in these recent lines, the solution may not be available online.

Added September 29: Candace Owens has now posted ep. 74, where we learn some more things. Starting with this:



That is where the photo of Beryl Finegan comes from. Kamala published that in her book, tagging it as her with her grandmother. But not so fast. That woman could be anyone. We have no other photos of Beryl, so we have no way of making a match. Candace found a death certificate in St. Andrew's parish, Kingston, for a Beryl Christie, died 1960, which would disprove that photo, since Kamala was born in 1964. That would put Beryl's birth in about 1921, which doesn't fit her listed year of 1917, but it does have another bit of supporting evidence, that being that the relative reporting the death is Muriel Murray. We know she was related to Murrays, since I found them in my genealogy searches. This cert says she was a spinster, but a spinster is simply an unmarried woman. Kamala's grandmother was unmarried at that point, having divorced a few years earlier. Most people think of a spinster as never married, but Merriam-Webster has nothing about "never married". We cannot know what the person who filled out this form was thinking, since "spinster" doesn't seem like a good answer to "condition" regardless. We would expect married, unmarried, single, or perhaps divorced, but not spinster.

According to Geneanet and other mainstream sources, Beryl Finegan died in 1995, but that second death certificate has even more problems, as Candace rightly discovers. It is from St. Ann parish, and the name is Beryl Finnegan, with two n's. The age at death is given as 81, but that puts the date of birth at 1914, which is also no match. Our Beryl Finegan is said to have died at age 77. Even worse, the relative reporting the death is listed as Douglas Finnegan, and there is no known Douglas Finnegan in Beryl's family. Beryl's father is listed as Patrick and he had no brothers or sons, which also rules out cousins. Candace says this may be a Beryl Finnegan Clark. Plus, her son Donald was still alive in 1995, so why wasn't he there for her burial? She also had two living granddaughters: where were they?

But all that analysis is unnecessary if we look more closely at the photo itself. It is another paste, isn't it? They are in a different light, as usual. The light is not only coming from different directions, it is different colors.



Beryl's highlights, as on her forehead, are very blue, while Kamala's aren't. Indicating the sky was clear and blue above Beryl, but white and cloudy above Kamala. But it can't be both, since they are standing under the same sky. The other problem is a non-match on chin shadows. We see a dark shadow beneath Beryl's chin, mainly to your left, indicating the light is casting strongly from above and to the right. But we don't see that with Kamala's chin shadow, which is barely there at all. But the strangest thing is that we can see the whites of Beryl's eyes clearly, but not Kamala's. That leads us to notice Kamala is squinting a lot more than Beryl is, again telling us she is in a lot more light. That is because it is late evening for Beryl's picture and mid-day for Kamala's picture.

**October 3**: Some people are telling me they can't see the fakes in these pictures. They aren't professional portrait painters like I am, so they can't tell the difference between blue sky reflecting off skin and things like that. Fair enough. OK, so try this one:



That is a Harris family photo <u>posted at Findagrave</u> by Mary Elizabeth del Valle Embry on the page of Oscar Harris. I guess Oscar is the one pasted in back-middle holding up a brewski, with smoke coming out of his left ear. Do I have to circle all the problems there? My red pen doesn't have enough ink. I am reminded of *The Matrix*, where Neo first comes into the real world and asks Morpheus why his eyes hurt. Morpheus says, "Because you have never used them". People coming to my site no doubt feel the same way, since they have to use their eyes for the first time. I guess Kamala is the one with the pink balloon, to make it easy for you. Following the bouncing balloon! But she was cut out with those little snub-nosed scissors you used in kindergarten and pasted in there with a Elmer's Glue-All. I love how the girl next to her has one brown leg and one white leg. Wow, that family really *was* a mix, down to the legs!

I sent Candace this paper several days ago and she has now posted three more episodes, ignoring me completely of course. What did you expect? I am going to give her a bit more time, but the Mileshammer is about to drop on her as well.

**Next day**: Candace has now posted ep. 78, where she talks on the phone with Donald's brother. Strangely, she refuses to name him, but it must be Christopher Harris, since she says he is much younger than Donald and is the son of Vioris. Even stranger is the way Candace is selling him, giving him 10 of 10 and saying she could tell he is honest—from a 10-minute phonecall? "He is honest", but claims he has never heard of his stepmother Beryl or his own grandmother Iris Finegan? Doesn't know who his own grandmother is? And Candace doesn't ask him the obvious question: well, Chris, if Iris isn't your paternal grandmother, WHO IS? Candace also describes this uncle as "a full brother" of Donald, but they can't be full brothers unless Donald's mother is also Vioris, which is not the mainstream claim. We also get no clarification of that from Candace, which is super weird. Why not just ask him the question she has had for many episodes: IS VIORIS THE MOTHER OF DONALD? She implies he is not, but never asks Chris that question directly. So the question is, why is Candace going so out of her way to cover for Chris? She complains in this very episode that the NBA players let Kamala slide their interview, that Matt Barnes didn't "put her feet to the fire", but when she has Chris on the phone, she can't remember to ask who his grandmother is? Just slipped her mind? She also "forgets" to ask him about the Jewish question. And of course nothing about the peerage.

Candace continually calls Kamala Irish in this segment. Kamala is not Irish, she is British peerage, from the Stuart lines of royalty. Candace's spiel in this segment is really oily and I know why, but I am not going to tell you just yet.

Candace does discover two big things in this segment, though she still doesn't hit them hard enough, in my opinion. The lesser thing she finds is Donald's sister Enid, but Enid's mother is listed as Pearline Currie. So Oscar Harris apparently had yet another wife or concubine. Enid and therefore Pearline also may be white, since Enid married a Hugh Ashton Watts—another very white peerage name. The Watts are actually related to the King, as we have seen many times before. We also find a third Iris: Iris May Shirley, mother of Hugh. She may be Iris *Mays* Shirley, of the Shirleys of Broward County, FL, where these Harrises also have relatives. So anyway, it is interesting that Tim Dowling doesn't list this wife or partner of Oscar and neither does any other site.

The more important thing Candace discovers is that Kamala claims in her book to have black aunts and uncles named Chris, Freddy and Mary.



I'm blessed with an amazing family. I'll never be able to thank Auntie Chris, Uncle Freddy, and Aunt Mary enough for their constant encouragement and support.

One problem: Kamala has no aunts or uncles with those names. Those are just friends of her mother that she called "auntie" or "uncle". No relation.

**October 17, 2024**: Candace finally returned to this today, posting an interview of Lady Colin Campbell with an old Jamaican local woman who met "Miss Beryl". She testifies the woman in Kamala's book is not that person. But the fact that Lady Campbell is involved just reminds me to ask, "why is Candace continuing to ignore the links to peerage here?" That's just as big a story as the fake photos, maybe bigger, but the reason Candace is ignoring it is that it pulls her in as well. Candace is an OWENS, and the Owens are Tudors. Candace is also half-white, as you can tell by looking at her, and her white lines are top peerage lines, which is exactly how she got where she is. These people, and no others, get promotion. Yes, it helps that she is pretty and fairly smart, but that isn't required. Look at Brian Stelter and Jamie Gangel and Dana Bash and Rachel Maddow. Like Tucker, Candace is in a glass house throwing stones when she starts criticizing people for their preference. That needed to be

said, but I do agree Kamala is much worse than Candace. Just as a matter of reading scripts, Candace is much better.

Candace is married to a very rich British peer, a white guy whose father is the Baron Michael Stahel Farmer, House of Lords. Candace's husband George was CEO of Parler. These people are also probably cloaked Jews, since the Baron Farmer is the deputy chair of the Council of Christians and Jews, founded by Chief Rabbi Hertz back in the 1940s. Farmer is a copper billionaire, a former protege of Manfred Kopelman, Jewish of course. In 1983 he joined Anglo Chemical, a part of Philipp Brothers/Salomon Brothers, who are again Jewish. In 1989 he started his own company, which became a subsidiary of Metallgesellschaft, the world's largest trader of copper and nickel. It was founded by Wilhelm Merton, and Wiki admits he was Jewish. He changed his name to Merton to hide that, since his father was Raphael Lyon Moses and his mother was a Cohen. The name Lyon links him to the Windsors and the British crown, since they are Bowes-Lyons.

Despite being a Baron, Michael Farmer is completely scrubbed at thepeerage.com. Darryl Lundy pretends not to know who his parents are. Since he is alive someone could just ask him. It takes no research. But they don't want you to know, a very bad sign. For more on Farmer, see here. I have not confirmed any of that, but it was top-ranked on a search (at Yandex, anyway), right after Wikipedia. Let see where it ranks at Google, that will tell us a lot. Guess what, Google has scrubbed it, indicating it is probably true.

\*Dowling is not consistent in this, and it appears the name in italics is sometimes the birthname or ne/nee, and sometimes it is a nickname. He should be consistent, to avoid this sort of confusion, but it seems to me he does it on purpose, to *create* confusion. He is creating a lot of confusion on purpose on these Harris pages.
