HOW KATHERINE MAHER



destroys the credibility of everything she touches

Katherine Maher is the current head of NPR, being the previous head of Wikipedia and various other government fronts. You may know her as the lady who said "the truth is a distraction from getting things done" and "the First Amendment is the number one challenge" in the way of battling disinformation and "a little bit tricky" getting around in the process of censorship. Yeah, she likes to say things like that at TED or the Atlantic Council or Tyranny Inc. Her parents Gordon Roberts Maher and Catherine Cecilia Queeney are also bigwigs, though not as big as Katherine. Gordon was a big finance guy in New York City, though Wikipedia scrubs him beyond that. We find elsewhere that *his* father James Joseph Maher, Sr., was an international IBM exec and post-war spy in

France. Mother was Marcia (Mickey) Roberts. Gordon's brother married a Greiss and his sister married a Steinhardt. Gordon himself was with Goldman Sachs and later UBS (Bank of Switzerland, of course), where he specialized in tankers (very large ships, you know, linking us again to Phoenician Navy). He died of alcoholism. Ceci Queeney (also a Kirby through her mother) came out of Columbia University to work at Lord&Taylor, but was later on the board of Sandy Hook Promise, pegging her as CIA or similar.

Steve Sailer at UNZ tries to convince us that although Bill Maher is Jewish, the name Maher is Irish and Katherine Maher is Irish. But it isn't and she isn't. She is Jewish. But let's move on. After highschool, Katherine Maher entered a two-year program at the American University of Cairo, allegedly to learn Arabic. Signal claims to promote secure and open global communication, mainly through advanced encryption. It was founded by the ridiculous Moxie Marlinspike, real name Matthew Rosenfeld, Jewish of course.
