
Joel the Ripper Was Another FAKE

I watched *Seinfeld* the other night, which is how I fell into this one. It was the episode where Elaine is dating a guy named Joel Rifkin, right around the time the famous NY serial killer of the same name is making national headlines. At one point, Kramer announces that the reason Rifkin became a serial killer is because he was adopted. If you're familiar with the show, you'll know that Kramer often comes closest to the truth, and I don't think that's by accident. His character is the classic Anti, created to delegitimize all conspiracy theories even as he reveals 80% of the truth. By hiding the most important 20%, he ends up looking like a nutty but endearing buffoon. In any case, he gives us a big clue by focusing on Rifkin's being adopted, though the scriptwriters knew we would read it all wrong. More on that later.


Following Rifkin's Wikipedia page, we are told his birth parents were both young college students, and his dad was an Army veteran, though we aren't given their names. Rifkin was adopted at three weeks old, and they even supply us with the adoption date: February 14. They had to throw that in there because Valentine's Day is a favorite Phoenician marker. Why else would we need to know the exact day he was adopted? His adoptive parents were an "upper-middle class" family from Long Island, Bernard and Jeanne (Granelles) Rifkin. Google's results, however, give his father as Benjamin, not Bernard. In fact, several online sources give him as Benjamin. As we see all the time with these guys, the researchers can't seem to settle on even basic facts about Rifkin's life, like his dad's name. It shouldn't be that difficult considering Rifkin is

still alive and someone could go and ask him. His adoptive parents were Jewish, which they admit, given that Rifkin is a variant of Rivkin, a Russian-Jewish surname. Does that mean Joel himself wasn't truly Jewish, since he was adopted? On the contrary, I do think he's Jewish, but not because he's a Rifkin.

[September 20: Miles here: a reader sent in some info he tripped over after reading this. It is the Wiki page of Sam Rifkin, who went under the name of Sam Lewis. Sam just happened to die in 1992, the year before Joel was arrested. Both Rifkins were born in New York City. Sam Rifkin's mother was maiden name Epstein, and we know that because Wiki admits his uncle was Rabbi Gershon Epstein. These Epsteins had emigrated recently from Russia, speaking only Yiddish. The Rifkins were wealthy furriers in New York. Sam became a pilot for TWA, flying stratoliners during WWII. After the war he was recruited for Operation Zebra as a weapons smuggler for Israel. Since this violated the arms embargo at the time, he must have been CIA. Only CIA can skirt laws like that. Sam and his superiors were convicted but skated, as usual. They were later pardoned by Clinton, proving that again. Two movies and six books were made about this. By the way, his superior was Al Schwimmer, which surname you will recognize from the *Friends* credits. And yes, that isn't an accident: he really was the grandfather of David Schwimmer, who played Ross. Wikipedia hides this relationship in the main text, though it is admitted in the sidebar. Al was really Adolph Schwimmer, and they admit he was an Israel intelligence agent, working for Mahal. Adolph was still working for Israel when *Friends* was on the air.

Sam Rifkin's wife was Jean and Joel Rifkin's mother was Jeanne.

Let's take a look at Joel himself. He's supposed to be serving a life sentence at Clinton Correctional Facility in New York. Unfortunately, the big computers haven't heard of Joel David Rifkin. He was allegedly born in 1959, making him 65 years old today.



InstantCheckMate only found one Joel Rifkin in the entire U.S. around age 65, but he's not quite the right age and has never lived in NY. An obituary confirms that this Joel Rifkin died in 2021 and looks nothing like our serial killer. InstantCheckMate has now inserted a listing for him, no doubt in response to this paper. But it only lists East Meadow, NY. No listing for Attica or Clinton, so the computer is still not aware he is in

jail. Also no listings for Uniondale, Farmingdale, or Brockport, where he allegedly went to school.

If we flip back to Wikipedia, we learn that Rifkin was arrested when they noticed a Mazda pickup without a license plate. Wow, Langley loves to recycle that idiotic story, don't they? Same story we got with Tim McVeigh two years later, remember? McVeigh had a genius IQ, but drove around in a car without plates, just asking to get pulled over? Same with Rifkin, who was no idiot. According to the mainstream story he was smart enough to kill 17 women and get away with it for four years, but too stupid to put a license plate on his truck.

We also learn prison officials decided Rifkin's notoriety would cause too much disruption, so Rifkin was "not allowed into the general prison population". So, if you ever were an inmate at Clinton Correctional Facility, you would have never seen Rifkin. That's a convenient cover if he was never there to begin with. More importantly, it's totally unconstitutional to keep a prisoner in solitary confinement for indefinite periods of time. In fact, we're told Rifkin sued for this very reason, but the appellate court ruled against him. Of course, this is all flagrantly against the laws of the land, but since Rifkin was never really imprisoned, they can make up whatever story suits their needs. Clinton looks like another maximum security prison with a whole fake wing for its fake prisoners, which have included <u>Son of Sam</u> and several other fake serial killers like <u>Tupac the gay Jewish rapper</u> and fake mobster Lucky Luciano.

What about Rifkin's victims? The big computers have never heard of his first victim, Heidi "Suzie" Balch. She simply doesn't show up in the database search. Neither does his next victim: there are no Julie Blackbirds from TX or NY. InstantCheckMate does pull a report for his last victim, Tiffany Bresciani, but apparently she never died – 53 is the age she would be today:



As it turns out, Tiffany was the girlfriend of Dave Insurgent, real name David Rubinstein, lead singer of Reagan Youth, an up-and-coming punk band at the time. Need I point out the Jewish name?



His parents were allegedly holocaust survivors. Judging by his father's photo, I'd say these Rubinsteins were more likely the financiers who staged the holocaust, not its victims.



One of his uncles was a Kon (Cohen), confirming all of that. Reagan Youth songs include "I Hate Hate", "Down With the New Aryans", and "Jesus Was a Pacifist", all of which reek of agitprop. If you didn't know the whole punk scene was a creation of U.S. Intelligence, well...now you do. Other bands they shared bills with included Dead Kennedys, U.S. Chaos, and Agnostic Front. The CIA couldn't be more obvious, could they? Rubinstein allegedly committed suicide by drug overdose shortly after his girlfriend's death, but since she never died, why should we suppose Rubinstein did? More likely he went deeper into Intel or just retired to some seaside town.



Bresciani was probably also Jewish. The Brescianis were nobles from Lombardy, famous for its Jewish banking industry. Antonio Bresciani (above) was a famous Jesuit priest and writer known for claiming a satanic conspiracy among secret societies and Jews to undermine Christianity. In a way he was right, of course, but as he himself was a Jesuit and Jew (see that face), he was just controlled opposition, pushing the Italian peasants to the right in an attempt to derail the popular workers' revolutions of 1848 that had started to gain traction in Italy. In other words, he was a stooge of the capitalists, who hated all forms of religion and workers' rights.

After Rifkin was arrested, police searched his home where he lived with his mom and sister. In their garage they found a wheelbarrow filled with blood, a pair of women's panties on the floor, and a chainsaw stained with blood and bits of human flesh. Neighbors stated they smelled strange odors emanating from the garage. All this in the same house where his mom and sister were living? Somehow they didn't notice the chainsaw covered in blood and human flesh? Or the panties lying on the floor? Seriously? "What's that weird smell in the garage? Could it be coming from that bloody chainsaw Joel's been using late at night?"

And a wheelbarrow filled with blood? You have to be kidding me! You have to keep blood refrigerated, you know, or it dries out and evaporates into a goo.

Here's another unbelievable fact: Rifkin allegedly dismembered his victims with an X-ACTO knife. That's right, an X-ACTO knife. He severed heads and limbs with a blade about an inch long, if that. I wasn't aware an X-ACTO knife could cut through bone. How long would that take? But wait, didn't they also tell us he used a chainsaw? Continuity, folks!

Rifkin's trial has all the usual signs of fakery, beginning with the date of his first court hearing: 8/11. Dead man's hand, chai. Opening arguments began on 4/20 – another favorite date, being Hitler's birthday. The case was presided over by Ira Wexner (Jewish), his attorney was Michael Soshnick (Jewish), and the prosecuting attorney was assistant DA Fred Klein (Jewish). Was anyone in that courtroom *not* Jewish? Notice, too, that the prosecutor was the *assistant* DA; why not the district attorney himself? Why pass off such a high-profile case to the assistant? We're also told Rifkin fired Soshnick because he always arrived late to court, and his partner John Lawrence would miss whole days of the trial. Again, is this normal behavior for such a high-profile case? The case was so notorious that *Seinfeld* wrote a whole episode around it. Do you think these two attorneys, given the chance to become famous from this nationally headlined case, would have acted so casually? Of course not. But if they knew the whole thing was a show, that's exactly how you'd expect them to act. Rifkin also knew the whole thing was a show, of course. He was such a bad actor that he was regularly seen napping during his court trial and even chuckling when evidence was presented.



That's a photo of him snoozing in court. The mainstream reading is that he was a soulless psychopath, but the far more logical conclusion, given everything we know of serial killers, is that he was just a crummy actor who couldn't keep up the farce. This bit is too good:

Rifkin, for his part, snored through much of the prosecutions case, a performance Lawrence blamed on allergies to the bologna sandwiches he ate in jail.

Baloney, hunh. Only a Langley scriptwriter could come up with this garbage. They even tell us it was a PERFORMANCE. Who performs? Actors.

As a witness for the prosecution, the DA brought in Dr. Park Dietz, a psychologist who also served as an expert witness in the Jeffrey Dahmer, Ted Kaczynski, and John Hinckley trials. Since all those trials were fake, we can peg Dietz immediately as just another phony for the CIA theater courts.



That's Dietz on the left, appearing on *Court TV*, brought to you by the CIA. We also learn this about Dietz:

...in 1987 he created the specialty of workplace violence prevention in founding Threat Assessment Group, Inc. (TAG), which specializes in analyzing and managing threatening behavior and communications, stalking, risks arising from domestic violence, and other abnormal activity in corporations, colleges, and schools. As of 2013, more than 20,000 senior corporate managers have attended TAG training seminars.

So, on the one hand Dietz is heavily promoting the idea of serial killers and other psychopaths across national media, while on the other hand he's raking in millions from his violence prevention programs. Isn't that the textbook definition of a racket? The "Our Team" page of the TAG website is lousy with former FBI agents, telling you where this is coming from. Specifically, they're all from the FBI's Behavioral Science Unit, which isn't what you think. They're not studying the behavior of serial killers, they're studying *your response* to the idea of serial killers, so they can see how to better manipulate you. In any case, it appears the whole serial killer project may be more FBI than CIA – though I don't doubt the CIA has gotten in on the action. Here's something else you should know about TAG; its VP of Business Development is Aaron Cohen. Enough said.

Here's another funny "coincidence". In the *Seinfeld* episode, Elaine tries to find new name ideas for her boyfriend from a sports magazine. Whose name does she pick out? O.J. Simpson.



Mind you, this was over a year *before* Nicole Brown was allegedly murdered. Did the show writers get an advance notice or something?

Here's another fun coincidence. A movie was made about Rifkin in 2018 titled *Joel*, written and directed by John R. Hand. Can you guess what day Hand was born? February 14. Hand is also a Jewish surname, and probably links John to Judge Learned Hand.



That's Professor Dumbledore – I mean Rifkin – today, but do you see the problem? Prisons don't generally allow hair or beards that long, for obvious reasons. If they allow beards, they're never more than an inch. Compare that photo to one several years ago:



Notice a difference? They forgot about the sewn-in nametag in the more recent photo, when they interviewed him for A&E. In other words, that's not a prison uniform. Prison uniforms include the inmate's name and ID number, for obvious reasons.

But I knew this was all fake before I ever researched it, thanks to *Seinfeld*. Think about it: would a nationally syndicated sitcom make light of a *real* mass murderer? Would the victims' families put up with their loved ones' deaths being turned into a joke on national TV? Would Rifkin himself put up with it, especially considering he had not yet been convicted of the crime? *Seinfeld* treated Rifkin as a serial killer while it was still an ongoing case, which means he could have sued for defamation. There's no way NBC would have approved the script *if it was a real criminal case*. Which can only mean it wasn't a real case. Confirming all this, you'll be interested to know the original airdate of the Rifkin episode was 11/18/93. Aces and eights again, of course. *Seinfeld* also made light of serial killers in a prior episode, "The Trip", where Kramer goes to Hollywood to become an actor and ends up becoming the prime suspect in the smog strangler case. They are telling you the truth right to your face: serial killers are ACTORS. To quote Jerry Seinfeld, EVERYTHING IS FAKE.

This is why Kramer's reminding us Rifkin was adopted is the big clue here. Bernard and Jeanne weren't his real parents, but they weren't his adoptive parents, either. They were all "adopted" for this script, complete with name changes. Bernard was really Benjamin, and Joel is really...who knows? But we know he's not Joel David Rifkin, since that person doesn't exist in the big computers. They admit his real father was military, which probably means he was military intelligence. Or he may have been FBI, since we've seen the serial killer project is largely FBI.
