

Minouche Shafik

This paper went immediately to #5 on the search “Minouche Shafik” at Yandex, ahead of CNN, Forbes, and the New York Times. Bing downlisted it to page 3. Yahoo downlisted it to page 5. Google censored it altogether, as we would expect.

The strangest person in the Mahmoud Khalil story (the Columbia University grad student Trump is trying to deport for leading pro-Palestinian protests) is not Khalil but former Columbia president Minouche Shafik. Shafik was president during the protests last summer.

[**March 29:** She was replaced by Katrina Armstrong last fall, but Armstrong just quit as well this week. Armstrong is of THE Armstrongs and is also a spook, having been involved in selling the fake Boston Marathon bombing as real. As a doctor and former dean of the medical school, she of course was also a big promoter of Pfizer and death shots, making her an accomplice in that crime against humanity.]

Born Nemat Talaat Shafik, she has been married twice but never took her husbands' names. Born in Egypt but raised in the US, she is now a Baroness and British dame (like a knight). How does that work? Wiki doesn't tell us, but she must have British citizenship which she can only have gotten through one of her parents.

She went to the London School of Economics and Oxford, going immediately from there into the World Bank, where she was a vice president by age 36—the youngest ever. It is even harder to understand how she advanced there so quickly considering the fact that she was in academia at the same time. We are told she was an adjunct professor of economics at Georgetown in DC from 1989 to 94, **the very same time** she was supposed to be at the World Bank. Yes, the World Bank is in DC, which means she didn't have to travel, but a young banker normally doesn't have time for a second career as a professor, especially one on the fast track. She was also a visiting professor at Wharton and

UPenn in the same period. After hitting VP at the World Bank, she suddenly moved to the British Department for International Development, becoming their Permanent Secretary at age 46. But again, Wiki tells us she was at the same time (2011-2014) also the Deputy Managing Director of the IMF. I don't see how she can be both, unless both jobs are just fronts. Around 2014 she quit both those jobs to join the Bank of England as their **first** Deputy Governor on Markets and Banking, which you have to admit sounds like another made-up title. That also didn't last long, since less than two years later she was tapped as Director of the London School of Economics. Five years later she became President of Columbia University.

So many questions, starting with, "Why would they hire this banker and baroness as President of Columbia?" It doesn't make any sense, beyond the fact they wanted to appoint a woman. We have seen this many times, where these rich ladies are appointed to big position after big position with zero qualifications and zero continuity. Of course the same can be said for the careers of many of these top Phoenician men, but it looks even more obvious to me with the women. This resume makes absolutely no sense. And why exactly was she knighted and raised to baroness? No answer, she just was.

How can someone be House of Lords when they were born in Egypt and raised in the US? Wiki and all other sources hide her parents, telling only that her father was a scientist and wealthy landowner in Egypt. Probably because she is related to Ahmed Shafik, head of the Egyptian Air Force and Prime Minister in 2011. These Shafiks are also Iranian royalty, being of the house of Pahlavi like the Shah. They are originally **Khans**, which we may translate as **Cohens**. You have to admit Minouche looks very Jewish in the photo above, especially in the nose, and she did go into banking, their favorite thing after hoaxing the Gentiles.

We do find these people in the British peerage, though it is not clear why. [See Shahriar Shafiq](#) (Shafik), son of Princess Pahlavi. Why is the Shah of Iran and his whole extended family in the British peerage? Well, a clue is that all of them back to the 19th century attended western schools. And I am not just talking about western colleges, I mean western schools in the Middle East. See for example the Jeanne D'Arc School for girls in Tehran, founded in 1900. It was ostensibly French, as you can see from the name (Joan of Arc), but the Pahlavi girls went there as well.

The Pahlavis in the peerage link us back to King Fuad of Egypt, telling us the Shafiks are close relatives of that family as well. And where do they come from? Surprisingly, [they come from Albania](#). The first was an **Abraham Aga**, shipping merchant from Golem, an old Phoenician stronghold on the Adriatic coast. His mother was a **Hanim**. You remember the flag of Albania, right?



The two-headed phoenix, pretending to be an eagle. I remind you the eagle never had two heads, but the phoenix always did, back to the time of Chaldea and Ancient India. Yes, the Fuads, and therefore the Shafiks, tie us to [my research on the Ottomans](#), whose rulers weren't even Arab or Turkish. They too were just British fronts, more than half Jewish, chosen because they had an Arab look to them:



That's Ismail Pasha, or Ismail the Magnificent, in a fake paste-up photo. They needed the glued-on fez because without it he just looks like a Jewish banker. But he does have the set of Phoenician breast pins, coincidentally the same set the current rulers of Europe wear, with Maltese flags and so on. He was ruler of Egypt and Sudan back to 1863, so you may want to ask yourself this: if these guys were Muslims from the East, why did they have the same medals we have? You wouldn't expect the King of England to be wearing the same medals as the Khedive of Egypt.

Perhaps it will help if I told you his mother was a Circassian, from southern Russia. Same area as the Khazars. But they tell you she was Circassian, not Khazarian, for obvious reasons: you may know the Khazars were not Muslim. They were pagans and many were Jews. So it doesn't fit this story. Other sources admit his mother may have been European. They give her name as Hoshiyar Qadin, but that looks like the usual fudge. That isn't a Circassian name. More likely it was something like Hosea Kidane, which is wholly Hebrew.

Minouche Shafik's first husband Mohamed El-Erian isn't in the peerage, being Egyptian/American, though he was President of Queen's College Cambridge and Manager of Harvard. So it seems we can't explain her being a baroness that way. But we can explain her early rise that way, since El-Erian was a huge bigshot in finance, coming out of IMF like her and then becoming CEO of PIMCO—the 6th largest asset management company in the world. So like Minouche, he must be top-shelf Phoenician. El-Erian headed up the International Center for Research on Women, so it is no surprise his wife got her fair share of promotion. The El-Erians are also El-Arians, a top Egyptian family. Also see Essam El-Erian, head of the fake Muslim Brotherhood, another front created to keep tensions high in the Middle East to benefit arms sales.

Speaking of arms sales, her second husband is Raffael Jovine, who Wiki calls a scientist. Well, maybe, but he is actually a biotech monster out of Booz Allen Hamilton. Here is just one of his red-flag lines on his current bio at LinkedIn:

Assessed the market to design a strategy for a major biochemical engineering company to enter the pharmaceutical market in the US resulting in the creation of novel vaccines.

Novel vaccines from Booz Allen, just what the world needs. Booz Allen is one of the most corrupt and

dangerous companies in the world, convicted of major fraud against the US government among many other things. That is admitted on their Wiki page. Booz is a defense contractor headquartered in McLean, VA, conveniently close to the CIA.

Bloomberg named it "the world's most profitable spy organization".^[16] According to an **Information Week** piece from 2002, Booz Allen had "more than one thousand former intelligence officers on its staff".^[14] According to its own website, the company employs more than 10,000 personnel who have cleared **Top Secret/SCI** background checks.^[17]

Wiki has a section called "controversies" on Booz Allen's page, but it starts at 2006. My older readers will laugh, since there are a litany of huge controversies going back to the founding in 1914. I seem to remember they are the ones who advised Goodyear to target trolleys and trains back then, so that people had to travel by car.

Jovine also appears to be American, so I don't think he is our link to British royalty either. Though he is in Camden Town, England, now, working for the misnamed Brilliant Planet:

Forests sequester vast amounts of carbon dioxide but grow very slowly. What if we could grow a mature forest in a few weeks, permanently sequester all the carbon it captures, then return a fortnight later and grow another mature forest on the same plot of land? This is the dream of **Brilliant Planet, a U.K. company commercializing a scalable nature-enhancing solution using forests of algae.**

Another conjob, in other words, created to bilk money from the treasury. According to LinkedIn, BrilliantPlanet has received many big UK government grants for that, including the largest agritech grant of 2020. Oi-effing-vay!

So, if we are judging Minouche by her husbands, it ain't looking too good.

But wait, Jovine isn't American, he just went to school here. He is German/British, being born in Munich. No Jovines in the peerage, though. Jovine doesn't have a German name, the name being Italian. It was originally Jovinel/Jovinelli, which seems to come from the Latin Juvenalis. . . but probably doesn't. More likely it is a slur of the word Jew, like the name Jewel, Jewitt, Jowett, etc. That fits our current story like a glove.

The Shafiks are also prominent in Palestine, so best guess is our lead actor here, Mahmoud Khalil, is related to his university president somehow. It looks to me like they are in this together, being cloaked Jews purposely blackwashing the Palestinian movement. Last time I checked, leading protests on university campuses is not against the law, so I don't really follow the logic of this whole story. On or off campus, it is clear that Palestinians have a right to protest Israeli aggression, especially when it is achieved on the back of a horrendously composed false flag like the Peace Party attack, where guys [flew in on kites and kidnapped a truckload of rubber-legged mannequins](#). And yes, Khalil, as a legal student with papers, has as much right to protest as anyone else on campus. The First Amendment definitely DOES apply to foreign students who are lawful permanent residents.

ICE agents have no legal authority to arrest campus protestors unless laws are broken, and we aren't told what laws have been broken. Trump can also not order the arrest of peaceful protestors, since that is just naked tyranny.

Khalil has not been charged with a crime,^[32] is not alleged to have engaged in any activity legally

prohibited to U.S. residents,[33] and authorities have not alleged he provided material support to a proscribed organization.[34]

On top of that, we are told Khalil is being held in Louisiana. What? Why there?

The mainstream is admitting this is all way over-the-top and out-of-bounds, while the alternative press is cheering it, but both are missing the more likely third-path explanation: this is all being staged so it doesn't have to be legal. It will never make it to the Supreme Court, so what's the difference? The important thing is not whether it is legal, it is whether it prejudices the American people against Palestinians and keeps the fake wars in the Middle East hot and profitable for defense contractors like Booz Allen. The government has been staging protests on campuses for many decades, and they now admit that. They were blackwashing hippies back in the 1960s with events much like this, though they at least took the time to manufacture some fake violence back then. See Operations Cointelpro and Chaos, which have been partially declassified. You can read about them at Wiki. In the current event about the worst they have accused him of is printing fliers with a Hamas logo. But again, that isn't illegal, even if he did. It would be like claiming it is illegal to wave a Russian flag on campus.

Even there, we can tell Khalil is a CIA actor and not a rich Palestinian, because if he were who we are told he is, he would know Hamas is just another creation of Mossad. Hamas is nothing more than a tarbaby.

We are told Khalil is being held for criticizing Zionism. But criticizing Zionism isn't a crime. You can't be arrested or held for it, so this makes no sense. But they obviously want you to think you can, since **the point of this fake event is scaring you into silence.** It's another bluff, one of thousands. They want you to think Trump will order your arrest for criticizing Jews, rich guys, guys with toupees, or guys who play golf really poorly.

Trump additionally signed executive order 14188, which calls for the deportation of students with visas who have broken laws during any anti-Israeli protest since the October 7, 2023 attacks.[20]

Note the number of the order: aces and eights, as usual, indicating it is more theater. But I remind you this order is redundant, since there are already laws allowing for deportation for breaking laws—supposing there is an actual conviction. So the order is meaningless.

Trump has allegedly canceled \$400 million in grants to Columbia as well, for allowing protests on their campus, but I don't believe that either. Most of Columbia's grants should probably be canceled for fraud and because Columbia is a private university—why should taxpayers be funding a private university that already charges way too much for tuition? But those grants aren't Presidential grants, funded out of the White House, so there is no way the President could unilaterally cancel them. This is just theater. Federal government grants are funded by Congress, so the only way the President could cancel is by line-item veto. But I guess everyone forgot how the government works on January 20 of this year. We are supposed to believe the President can now micro-manage every private university in the nation, based on some note he got from Israel or the ADL.

We can also tell this is more vaudeville by one of Khalil's quotes:

"There is, of course, no place for antisemitism".

You have to laugh. We are supposed to believe that even Palestinians can't be mad at Jews. This bad boy at Columbia wouldn't dream of thinking bad thoughts about Israel. The Jews have to put their words even in the mouths of their enemies, showing how bad they are at staging these things.

Even anti-Semitism isn't a crime. You are free to dislike Jews if you want. You aren't legally required to like anyone. No one can legislate your ideas or words, unless you are joining them to violent and illegal *action*. No, you aren't allowed to harass people, but calling people out for breaking the law is not harassment. It is also not defamation. You are not legally required to believe lies or sit idly by while people harass, gaslight, and suppress you. Nor are you required to swallow everything the government shoves down your throat, such as this story. I am not harassing or defaming the CIA or FBI or its agents by blowing their cover, for instance. That is absurd. The truth is, they have harassed, gaslighted, pillaged and defamed me my whole life, and you as well, so we are just fighting back.

What you may not know is that over 3000 protestors have allegedly been arrested on 60 US campuses in the past year, including professors and other university staff, simply for being there. That would be the real crime here. . . if I believed it was true. But again, I don't. What this current story tells us is that all these arrests were probably staged as well, as part of Operation Chaos, to foment discord, spread fear and division, blackwash Palestine and protestors in general, and keep you silent and off the street. I have shown you over the past two decades that the government has long been running these big fake events, many of them on campuses, for more than a century. All to control the opposition. The best way to dodge a revolution is to fake it yourself. The best way to dodge a protest is to manufacture one and then break it up by force. They admit at Wikipedia that the FBI and CIA have their own schools for agents, where they teach them to be fake protestors and revolutionaries. They don't really need Hoover University anymore, since the CIA has taken over most universities in the interim, running any and all events they like with no opposition. We saw this more recently with the Black Lives Matter protests on and off campus, and the George Floyd protests, all of which were manufactured. Same for the attacks on Target and other stores, which were staged. Most of the events now in the news are staged by one government entity or another. All the world is a stage, as they say, except that now it is literally true. Half the people you meet in real life and 90% you meet online are government actors.
